**NEW YORK CITY:** At Climate Week NYC, Ceres will bring together business and policy leaders with bipartisan perspectives to explore the challenges and opportunities in advancing climate action. Ceres at Climate Week includes a full-day residency at the Nest Climate Campus on Sept. 24, featuring a main stage event - Championing the Clean Economy: Corporate Action and Protecting the Freedom to Invest - followed by a roundtable discussion and media availability.

Three former Republican members of Congress and thought leaders from center-right organizations will champion efforts to protect the long-standing rights of investors and companies to consider all financial risks in decision-making. It also comes as frequent and costly extreme weather events continue. At the same time, recent analyses show positive trends of sustained clean energy momentum.
